- It will work according to the specific direction given by the trust regarding admission policy. However admission will be made as per merit without discretion of caste, creed, religion and region.

- It shall above both short term and long term programmes for the improvement of the school. IV.
- It shall have the power for making appointment of teachers and non-teaching staffs. ٧.
- It shall exercise financial powers beyond those delegated to the principal within the budgetary all VI. control of trust.
- It shall have the power to stock of academic programmes and progress of the principal. VII.
- It shall guide to the principal to maintain tone and discipline in the school. VIII.
- It shall ensure that the norms given in the Act of the state and by the CBSE regarding terms and IX. condition of service and other rules governing recoginition /affiliation of the school are strictly adhered to .
- It shall ensure that the school gets furniture, Science equipment, Library, books and other X. teaching aids and the requisite material in adequate quantity and on time .
- It shall exercise power to take disciplinary action against staff. XI.
- It shall have power to sanction leave to head of the institution including casual leave . XII.
- It shall ensure that no financial irregularity is contributed or any irregular procedure with regard XIII. admission.
- It shall have to power to propose to the social condition of tution fee and other annual charges XIV. \* and also review the budget of the school presented by the principal forwarding the same to the foundation for approval.
